

**Terms and Conditions for
The “It’s So Easy to Be Green!” Online Bill Pay Promotion**

How to receive your Reward with Online Bill Pay Enrollment and Use:

Eligibility: The “It’s So Easy to Be Green!” promotion is offered only at participating Financial Institutions to their Consumers (“End Users”) with an existing checking account in good standing or who opens a new eligible checking account and enrolls for the first time for the Online Bill Pay service during the Promotional Period. End Users must be a lawful permanent resident of the United States, 18 years of age or older with a unique, personal and valid social security number and must not be considered a minor in their state of residence.

2. One Credit of \$10.00 will apply per eligible End User regardless of the number of End User owned eligible and active checking accounts with Online Bill Pay.
3. A \$10.00 credit will be deposited into End User’s eligible checking account on or about December 15, 2008. For End Users with multiple checking accounts used for online bill pay with the participating Financial Institution, the Credit will be deposited into one active account with Online Bill Pay.
4. Enrollments made under multiple identities or through the use of any agent or other device or artifice to participate multiple times in violation of these Terms and Conditions will be deemed invalid.
5. Credits will not be given to End Users who do not meet these Terms and Conditions and that do not pay ten (10) online bill payments through the Sponsor’s Online Bill Pay service during the Promotion Period.
6. Recipient of the Credit is deemed to be the End User whose name appears on the Online Bill Pay registration. A third party vendor will be used by Digital Insight to facilitate the deposit of the Credit. A third party vendor will be used by Digital Insight to facilitate the deposit of the Credit. Our contracts with third party vendors outline the appropriate use and handling of your information and prohibit third parties from using any of your personal information for purposes unrelated to the product or service for which they’ve been contracted.
