1. Web Kid's Page. Digital Insight will provide Customer with a Web Kid's Page as described below.

Customer can choose one Template, two games, and two calculators from our library that will be integrated with an existing Web Site or AXIS eCommerce site hosted by Digital Insight. AXIS eCommerce implementations will be integrated under the top branding and navigation frame. Web Site implementations will open within a new browser session and feature a single link to return to Customer's home page.

Customer responsibilities:

- Select Kid's Page Template from Digital Insight's library
- Provide up to one page of text
- Select two Kid's Games and two Kid's Calculators from Digital Insight's library

Digital Insight Responsibilities:

- Integrate Customer selected Kid's Page Template, Kid's Games, Kid's Calculators, with supplied text on Custom's Web Site or AXIS eCommerce Site.

**Implementation Fees (One-time Charges):**

Web Kid's Page Set-up Fee \$900

**Payment terms:**

- Setup Fee shall be due upon execution of this Amendment.

**Entire Amendment.** This Amendment constitutes an agreement by both parties with respect to the Web Kid's Page Amendment and supersedes all prior written or oral and all contemporaneous oral agreements, understandings and negotiations between the parties with respect to this Amendment. However, this Amendment shall not supercede nor override any other Amendment related to the original Master Services Agreement referenced above.
